The Judge John R. **Brown Admiralty Moot Court Competition**

The University of Richmond T.C. Williams School of Law is co-sponsoring with The University of Texas School of Law the fourth annual Judge John R. Brown Admiralty Moot Court Competition. Teams from schools around the country will compete in appellate advocacy involving issues of maritime law and practice. A synopses of the 1996 problem is available on the Internet at:

This competition is made possible through the generosity of members of the bar active in international and maritime law. Judge Brown served on the United States Court of Appeals for the Fifth Circuit from 1955 until his death in 1993, and was one of the nation's most prominent admiralty judges.

Teams will compete in oral argument at the Lewis F. Powell United States Courthouse in Richmond, beginning on Thursday, February 27, 1997 and ending with the Championship Round on Saturday, March 1, 1997, in the en banc courtroom of the U.S. Court of Appeals for the Fourth Circuit. The problem went to competitors in early December and a comprehensive bench memorandum to judges in January.

Teams argue in three seeding rounds before winners advance through quarter- and semi-final rounds to the championship round. The tournament closes Saturday evening with a banquet honoring the winners. For more information see Mary Catherine Hart of the Moot Court Board or Professor J.P. Jones.
