# **Quiet, Please!**

As we approach final exams, we would like to remind you of some guidelines regarding talking in the Law Library.

You may have <u>quiet</u> conversations in the front part of the Law Library where the Circulation, Reference, and Computer Help desks are located. Conversations in this area should be conducted in a lower, quieter tone of voice than what you would use outside the library.

After passing through the doors by the Reference Desk, you then enter <u>quiet zones</u>. Students studying at the tables near the first floor rest rooms expect that area to be quiet. The carrel areas (after you pass the doors by the main stairwell) are <u>total quiet zones</u>. Also, please do not hold conversations by the main stairwell since talking there disturbs students on both the main and second floors.

If you need to study with other students, please remember that there are study rooms in the basement of the library where you can have conversations with other students.

Your fellow students appreciate very much having a quiet Law Library where they can study and research without interruptions.

#### **Exam Reminders**

If you are required to use Exam4 to take your exams, please download the software and take a practice exam. If your computer has any problems running the software, visit the Computer Help Desk immediately. When taking the practice exam, pay particular attention to the multiple choice answer sheet, as you may be required to use it during exams. Also, make sure you insert an answer separator between each written exam answer. Some professors will have a word count limit per question – click the box to show your word count, which will give you real-time data on hos much you have written.

- 3. NAME YOUR DOCUMENT as soon as you open your word processor.
- 4. For safety's sake, save the document often to an online location (netfiles, Dropbox, Google Drive, etc.).
