The Leadership Library

The Law Library recently acquired direct access to [The Leadership Library](#) (sometimes referred to as the “Yellow Books”). The Leadership Library provides online search capabilities for legal, government, business, media, and nonprofit professionals by name, organization, or keyword. Search results can include direct-dial telephone numbers, addresses, career histories, education backgrounds, board affiliations, areas of responsibility, or contact-specific emails. You can also retrieve information about issues covered on the Hill, media beat, job function, office specialty, legal specialty, lobbying specialty, or alma mater.

Study Room Reservations
