**Law Library now open at 6:30 a.m.:**

## E-Resource of the Month: Making of Modern Law

The Muse Law Library now has an electronic subscription to the Making of Modern Law Primary Sources I & II, which contains constitutional convention materials, including reports, journals, proceedings, debates, rules of order, and information for the use of delegates; the text of enacted and proposed city charters and ordinances. The database is available in two parts but is cross-searched as the default search mode.
