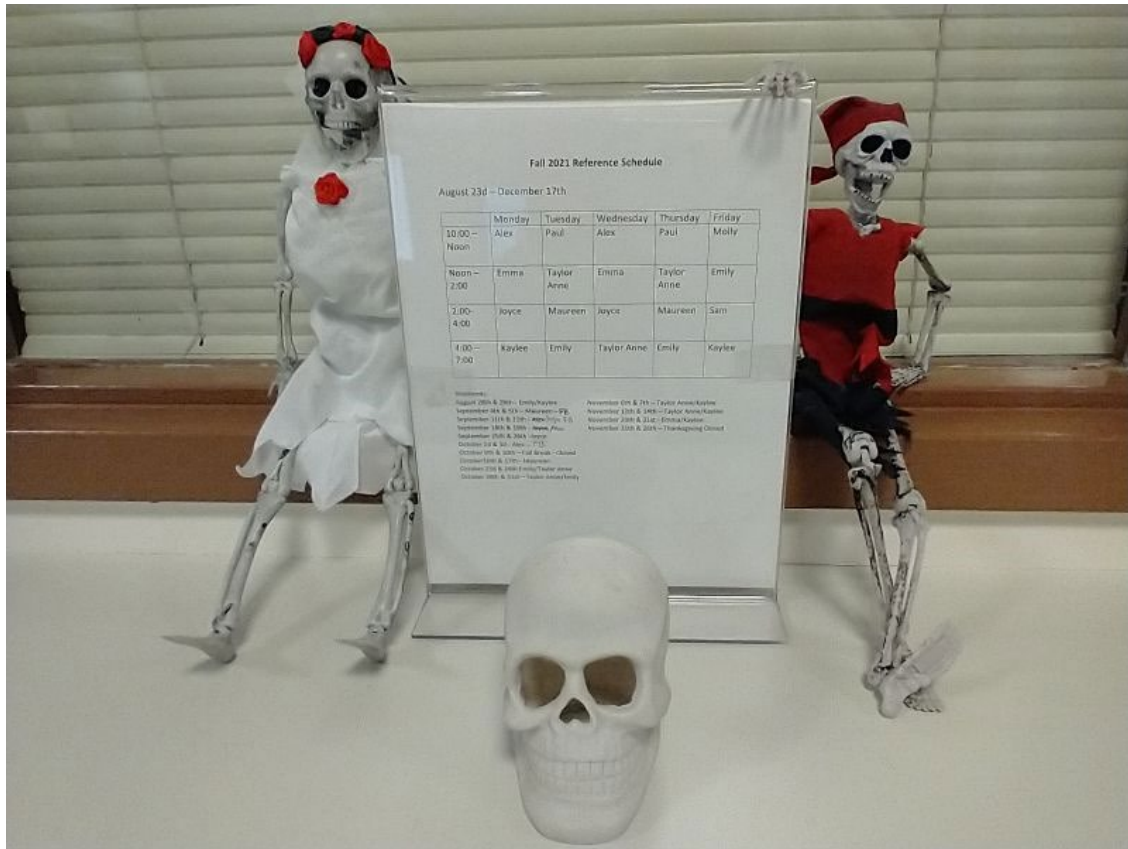
Director's Message

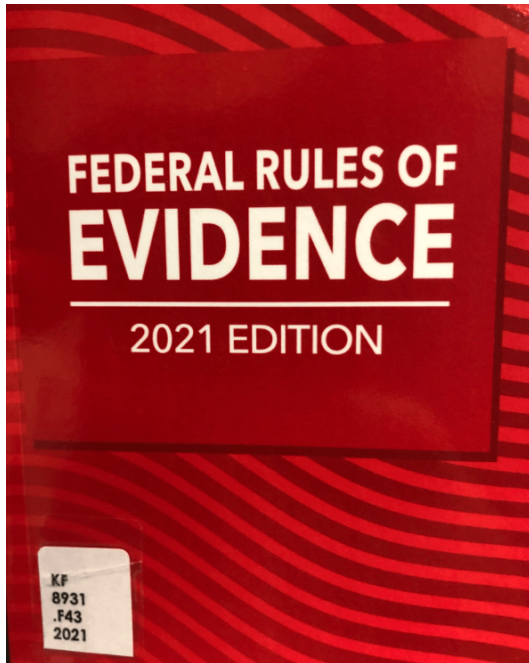

You Deserve a Treat!

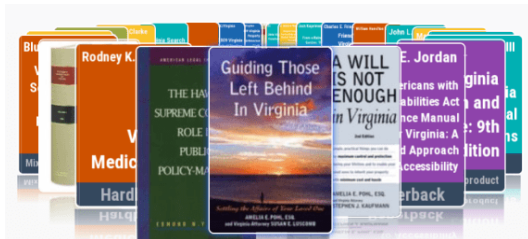

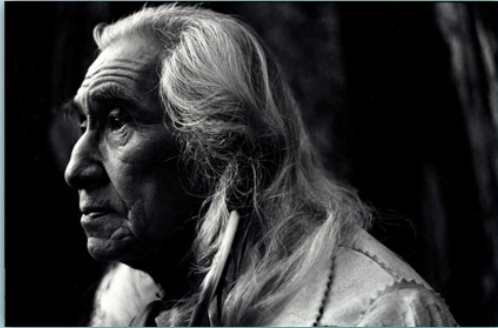


Turning Research Lemons into Lemonade

Sometimes you get a research project that seemingly turns into a dead end, but with a little creativity and persistence, you can turn things around. I had just such a research project in 2020, when a professor from Arts and Sciences, Atiya Husain, asked me to find trial transcripts from a number of criminal cases from the 1970s involving Assata Shakur*, then known as Joanne Chesimard, a member of the Black Liberation Army, for a book she was writing on the FBI Most Wanted list.
