The "official" closing of the Meeting and the handing over of the gavel to the new president, Darcy Kirk, will take place on Tuesday afternoon in the Exhibit Hall.

So no matter how you view May, as a beginning, an ending, or even as no more than the middle of your year, I look forward with anticipation to seeing you at the Annual Meeting in a few short weeks.
