This year, you have not only 64 excellent programs, four fabulous workshops, and a myriad of special interest section offerings but also the second Private Law Libraries Special Interest Section summit and the Conference of the Chinese and American Forum on Legal Information and Law Libraries to look forward to. I hope that you will be able to participate in the rich educational and cultural offerings that this year's Annual Meeting will provide. So, I invite you to join me as I sit here shivering on a cold January morning in looking forward with hope to the warmth, the renewal, and the new beginnings that await us this spring!
